I. COMPANY PROFILE

The company has incorporated under the Companies Act, 2013 as India Optel Limited (IOL) having registered office at OFILDD Campus, Raipur, Dehradun-248008 with 3 production units namely, a) Ordnance Factory Chandigarh, b) Ordnance factory Dehradun and c) Opto-Electronics Factory Dehradun.

IOL is a schedule - 'B' CPSE with the administrative jurisdiction of Department of Defence Production, Ministry of Defence.

The major products being manufactured by the company are sights, optical devices, components for night vision devices, laser sighting devices, wires and cable assemblies and fifle scopes.

The company has 2549 employees on deemed deputation as on 31.03.2024.

The authorized and paid up share capital of the Company was Rs. 6500 crore and Rs. 5905.61 crore respectively as on 31.03.2024.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Operations) is a member of the Board of Directors and reports to Chairman & Managing Director. He/She is responsible for overall operations of the company including planning & Production, Strategic planning for expanding the business horizon of the company, Quality Assurance, Modernization, Project management and Indeginization. His responsibilities would also include ensuring effective and efficient implementation of production plans/operations, timely and

cost effective completion of the projects/contracts, upgradation of capabilities in the manufacturing divisions, modernization and promoting indigenisation.

The applicant should possess at least five years technical/ operational/ production planning experience during the last ten years at a senior level of management in the Electronics & Communication Industry.

3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
